**STIPULATION FOR
RECIPROCAL DISCIPLINE**

THIS STIPULATION is entered into by and between Martin A. Cole, Director of the Office of Lawyers Professional Responsibility, hereinafter Director, and Patti Jo Jensen, attorney, hereinafter respondent.

WHEREAS, respondent has concluded it is in respondent's best interest to enter into this stipulation,

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED by and between the undersigned as follows:

1. It is understood that respondent has certain rights pursuant to Rule 12(d), Rules on Lawyers Professional Responsibility (RLPR). Respondent waives those rights and agrees to the Court's immediate issuance of an order for reciprocal discipline consistent with this stipulation. Respondent hereby admits service of the petition for reciprocal discipline.

2. Respondent unconditionally admits the allegations of the petition which may be summarized as follows: On September 18, 2012, the North Dakota Supreme


Court suspended respondent from the practice of law for 30 days, effective November 1, 2012. Respondent's suspension was based upon her failure to act with adequate diligence and to communicate adequately with a client, in violation of Rules 1.3 and 1.4, North Dakota Rules of Professional Conduct.

3. Respondent understands that by entering into this stipulation, the Director is not making any representations as to the sanction the Court will impose.

4. The Director and respondent join in recommending that reciprocal discipline of a 30-day suspension, effective 14 days from the date of the Supreme Court's order, is appropriate. The reinstatement hearing provided for in Rule 18, RLPR, is waived. Reinstatement is conditioned upon: (a) payment of costs in the amount of \$900 pursuant to Rule 24(d), RLPR; (b) compliance with Rule 26, RLPR; (c) successful completion of the professional responsibility examination pursuant to Rule 18(e); and (d) satisfaction of the continuing legal education requirements pursuant to Rule 18(e), RLPR.


5. This stipulation is entered into by respondent freely and voluntarily, without any coercion, duress or representations by any person except as contained herein.

6. Respondent hereby acknowledges receipt of a copy of this stipulation.






